Order

In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Eastern Regional Committee grants recognition to **Ursuline Primary Teachers Education College, Lohardaga (Jharkhand)** for **Primary Teachers' Training Certificate Course** of Two years duration from the academic session 2001-2002 with an annual intake of 50 students, subject to fulfilling the following conditions:

1. The Institution shall function with eight teaching staff and other supporting staff possessing the qualifications as laid down in the NCTE norms and in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
2. The institution shall ensure library with 1500 books, laboratories, Hostel and other instructional infrastructure as per the NCTE norms within six months.
3. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/ State Government.
4. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
5. Curriculum transaction, including practical work/activities, should be organised as per the NCTE norms and standards for the course and the requirements of the affiliating university/examining body.
6. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
7. The institution shall maintain endowment and reserve fund as per NCTE norms within one year.
8. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 7 above.

If Ursuline Primary Teachers Education College, Lohardaga (Jharkhand) contravenes any of the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder, or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.



Order

In terms of Section 15(1) of the NCTE Act, 1993 Ursuline Primary Teachers Education College, Lohardaga, Pin – 835 302, Jharkhand, had submitted an application to the Eastern Regional Committee of NCTE for grant of permission for an additional intake of 50 in the existing PTT Course of two years duration from the academic session 2004-2006.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:

- i. The institution has acquired the land for setting up the teacher education institution.
- ii. The institution has constructed the building for conducting the course on the above mentioned land
- iii. The institution has selected one Principal and 09(nine) faculty member for the said course and the list of teaching is duly countersigned by affiliating body.

3. Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **Ursuline Primary Teachers Education College, Lohardaga, Pin – 835 302, Jharkhand**, for existing PTT Course of two years duration from the academic session 2005-2007 with an additional intake of **50 (fifty)** thus total annual intake of 100 (one hundred) students subject to the compliance of the following conditions before the commencement of the course:

- a. The institution will ensure that Principal and at least 10 (ten) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent the Eastern Regional Committee within one month of the commencement of the course.
- b. The institution shall submit a list of teaching staff duly countersigned by the competent authority of the affiliating body within one month of the commencement of the course.
- c. The institution shall pay salary to the teaching staff as prescribed by State Govt.
- d. The institution shall within one month of the receipt of recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (five years) in a Nationalised Bank to be operated along with an official of the Regional Committee.
- e. The institution shall create a Reserve Fund for an amount equal to three months salary of the teachers and staff within one month from the date of issue of this order and maintain in the form of FDR in favour of the management of the institution for a period of not less than sixty months (five years) in a Nationalised Bank.
- f. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time



Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.

The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
